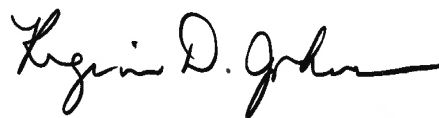
ORC Section 3501.30 requires signs to be placed no closer than one hundred feet from the outside entrance to a polling place. Please review the attached page for the proper placement of signs.

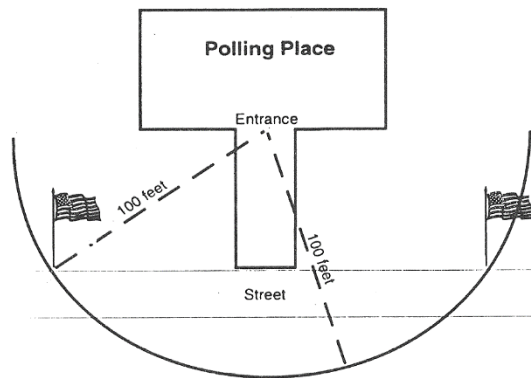

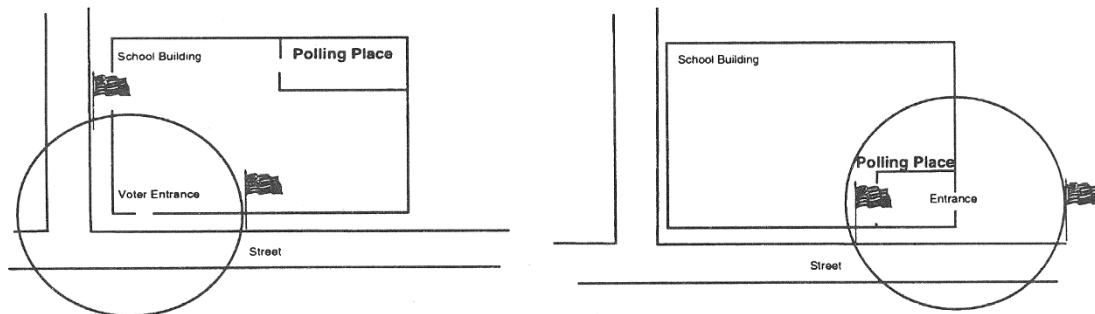

EXAMPLE FLAG PLACEMENT



In this diagram, the polling place is located close to the street. Notice that the area within which loitering is prohibited extends across the street. It is sometimes thought that loitering near a polling place is prohibited only on the side of the street where the polling place is located. Actually, it extends 100 feet from the polling place, whatever that may include.



In the above two diagrams, the polling place is located in a large building. If voters must walk through the building to reach the room where the polling place is located, the entire building should be considered a polling place. Loitering is prohibited within 100 feet of the entrance or entrances voters must use, as well as within the entire building.
