Dear Taxpayer:

Thank you for your interest in paying your property taxes by Automatic Withdrawal. The Stark County Treasurer offers two plans to pay your property taxes by Automatic Withdrawal; Semiannual or Monthly Prepay. The Semiannual plan is for taxpayers who want to continue to pay their taxes twice-a-year. The Monthly Prepayment plan is for taxpayers who want to pay their Property Taxes in monthly installments rather than two large semiannual payments.

*To qualify for an Automatic Withdrawal plan, you must pay your 2025 Second Half Tax Bill by the July 15, 2026 due date. **Please note - There are no fees for the automatic withdraw plans.***

If you select the Semiannual plan, your First Half Property Taxes will be withdrawn from your checking or savings account on the second Wednesday of February, and your Second Half Property Taxes will be withdrawn on the second Wednesday of July.

If you select the Monthly Prepayment plan, your half-year taxes are divided into five (5) installments, and the following schedule applies:

- August / September – The 2026 First Half Prepayment schedule letters will be mailed by Labor Day.
- September 15th, October 15th, November 16th, and December 15th, 2026 – Monthly Prepayments will be withdrawn for the 2026 First Half Property Tax Bills.
- January 2027 – The 2026 First Half Property Tax Bills will be mailed. No Monthly Prepayment withdrawal occurs. In addition, the 2026 Spring Monthly Prepayment schedule letters will be mailed.
- February 2027 – **Two withdrawals** occur:
 - **First withdrawal** – Wednesday, February 10, 2027-, to pay off the First Half Property Tax Bills.
 - **Second withdrawal** – Friday, February 26, 2027, the first Prepayment for Second Half Taxes.
- March 15th, April 15th, and May 17th, 2027 – Monthly Prepayments will be withdrawn for the 2026 Second Half Property Tax Bills.
- June 2027 – The 2026 Second Half Property Tax Bills will be mailed. No Monthly Prepayment withdrawal occurs.
- July 2027 – **One withdrawal** occurs on Wednesday, July 07, 2027, to pay off 2026 Second Half Tax Bills.
- August – No Monthly Prepayment withdrawal occurs.

Here is the estimated Monthly Prepayment amount for your Parcel Number:

Please pay your Tax Bill by the July 15, 2026, due date.

Your Monthly Prepayment plan will start on September 15th for the 2026 First Half Property Taxes that will be due on February 17th.

Payment of Property Taxes by Automatic Withdrawal

The Stark County Treasurer accepts payments by Automatic Withdrawal from a checking or savings account. Please initial the Automatic Withdrawal plan you prefer:

_____ **Semiannual Installments:** Automatic Withdrawals from a checking or savings account will occur twice a year. A Property Tax Bill will be mailed in January to show the withdrawal amount for the First Half which will occur on the second Wednesday in February, and in June to show the withdrawal amount for the Second Half which will occur on the second Wednesday in July.

_____ **Monthly Installments:** Automatic Withdrawals from a checking or savings account will occur on the 15th of the month. (If the 15th is on a holiday or weekend, the withdrawal will occur on the next business day.) A letter will be mailed in early September with the prepayment schedule for the First Half Taxes. A second letter will be mailed in January with the First Half Property Tax Bills with the prepayment schedule for the Second Half Taxes. Property Tax Bills will be mailed; 1) in January to show the final withdrawal amount and date to pay off First Half, and 2) in June to show the final withdrawal amount and date to pay off Second Half.

If a withdrawal is declined by a financial institution for any reason, this agreement is voided and Property Taxes must be paid with a check or money order.
